# State of Maryland 2023 Hate Bias Report

## I. Scope

Public Safety Article Title 2-307 tasks all law enforcement agencies within the State of Maryland and the Office of the State Fire Marshal to provide the Maryland Department of State Police (MDSP) with information relating to incidents seemingly directed against an individual or group because of race, color, religious beliefs, sexual orientation, gender, disability, national origin, or homelessness. In compliance with that requirement, the MDSP, in partnership with the Maryland Coordination and Analysis Center (MCAC), has produced this 2023 Hate Bias Report. It contains an overview of trends in hate bias-related incidents within the State of Maryland including a statistical representation of incidents and their associated victims, offenders, injuries, weapons, and property damage. This report also includes a historical analysis of total incident data compared with total verified data from the previous 10 years. The information is limited to hate bias incidents reported to Maryland law enforcement.

## II. Methodology

The State of Maryland meets National Uniform Crime Reporting (UCR) requirements via the Maryland Statewide Uniform Crime Reporting Program. This program provides procedures and the collection mechanism for hate bias incidents based on the following: Race/Ethnicity/Ancestry (R/E/A), Religion, Sexual Orientation, Disability, Gender, Gender Identity, and Homeless Status. Law enforcement agencies submit incident data to MDSP Central Records Division for data compilation using the Maryland State UCR Portal which has replaced the Maryland Supplementary Hate Bias Incident Report Form. This data is analyzed and findings are released to the public in this publication annually.

While the Federal Bureau of Investigation (FBI) UCR Program compiles hate crime data regarding criminal offenses motivated by the offender's bias, Maryland Public Safety Article Title 2-307 requires the collection of data on hate crimes as well as non-criminal hate bias incidents. For this reason, the FBI's statistics on hate crimes may differ from Maryland's hate bias statistics.

Incident-based data includes events that are perceived by the victim(s) or the investigating law enforcement officer(s) as motivated by hate or bias.

Such incidents may or may not be considered criminal activity. Crime-based data pertains to hate bias-related crimes, which are recorded as hate or bias incidents but, more specifically, involve offenses that can result in arrests. Hate crime definitions often encompass not only violence against individuals or groups, but also crimes against property, such as arson or vandalism, particularly those directed against community centers or houses of worship. In order to provide a more comprehensive overview of hate bias-related activity in Maryland, crime-based and incident-based data have been combined in this report.

When an incident is reported, the following criteria, among others, can be used to determine if the incident is bias-related:

- A review of the totality of the circumstances.
- A review of the motives.
- A display or expression of any bias-related symbols, words, or acts.
- The victim's perception and/or statements of any offender(s) or witness(es).
- A prior history of similar incidents in the same geographic area or against the same victim(s).
- The demographics of the area of occurrence.

Identifying the offender's subjective motivation can make it difficult to distinguish a hate bias-related incident. An incident can be verified through an investigation of the accused person or through eyewitness reports of a crime. The determination whether to charge a hate crime is at the discretion of law enforcement and prosecutors. The presence of any of the following criteria may be indicators that an incident is hate bias motivated and additional investigation is necessary:

- Similar incidents in or around the same location or neighborhood indicating a possible pattern.

- *Perceptions of the victim(s) and witness(es) about the incident* – This is one of the single most important factors to consider. However, victims may not readily recognize that the incident was motivated by bias.
- *Perpetrator’s comments, gestures, or written statements reflect bias* including graffiti, drawings, and symbols used.
- *Differences between perpetrator and victim, whether actual or perceived by the perpetrator* – Victims and perpetrators may appear to be from the same race, ethnicity, or religion, but it is the perpetrator’s perception of difference that motivates the behavior constituting an incident.
- Victim was engaged in activities promoting their community or group.
- Incident coincided with a holiday or date of particular significance to a group.
- Localized activities of organized hate group(s) or the absence of any other motive(s) such as economic gain.

Some incidents are not clearly identified as hate bias. However, investigative efforts may reveal the incident is hate bias motivated. Depending on the outcome of the follow-up investigation, hate bias incidents are classified as verified, inconclusive, or unfounded.

- *Verified Incident* – An incident committed against a person or property where the investigation leads a reasonable and prudent person to conclude that the offender’s actions were motivated, in whole or in part, by their bias against a person’s race/ethnicity/ancestry (R/E/A), religion, sexual orientation, disability, gender, gender identity, or homeless status.
- *Inconclusive Incident* – An incident where the evidence is conflicting, incomplete, or otherwise insufficient to classify as verified.
- *Unfounded Incident* – An incident in which the evidence or investigation definitively indicates that it was not motivated by bias against a person’s R/E/A, religion, sexual orientation, disability, gender, gender identity, or homeless status, or that the incident did not occur.

### Data Declaration

The data contained in this report comes from the Maryland State UCR Portal. Information includes date,

time, incident type, bias motivation, clearance, victim and offender demographics, location, weapons used, injuries, value of property damage, and a written summary of the incident, amongst other things.

In 2012, Maryland added Homeless Status as a protected category under the hate bias statute. In 2015, Gender and Gender Identity were also added. These additions have not made a significant impact on overall reporting as R/E/A, Religion, and Sexual Orientation largely account for bias motivations from the previous 10 years.

Other revisions to categories have included:

- Victim and offender race category was revised to White, Black or African American, American Indian or Alaska Native, Asian, and Native Hawaiian or Other Pacific Islander, multiple races, or unknown.
- The revised ethnicity categories are Hispanic or Latino, Not Hispanic or Latino, multiple ethnicities, or unknown.
- The following religious bias types were added: Anti-Buddhist, Anti-Eastern Orthodox (Greek, Russian, etc.), Anti-Hindu, Anti-Jehovah’s Witness, Anti-Mormon, Anti-Other Christian, and Anti-Sikh.
- Bias Motivation Code categories were revised to include: R/E/A, Religion, Sexual Orientation, Disability, Gender, and Gender Identity. The previous Bias Motivation Code, Ethnicity (alone), was eliminated. Other codes, including those for Location and Property Damage Type, were updated as well.

The reports are collected by the MDSP’s Central Records Division as mandated by law and are then provided to the MCAC. If a hate bias incident occurs and is not reported to law enforcement, an incident report is not filled out and is not submitted. All information included in this report is analyzed based on the information entered into the Maryland State UCR Portal and submitted to the MDSP. This analysis is current as of 1 July 2024. Incident reports from 2023 received after 1 July 2024 will be reflected in the 2024 Hate Bias Report.

No specific addresses or locations are collected except the incident ZIP Code. No names or personal identifiable information are reported to maintain confidentiality. All percentages are rounded to the nearest tenth of a percent.

### III. Executive Summary

There were a total of 951 hate bias incidents reported by Maryland law enforcement during 2023; of those, 270 were verified.

#### Key Findings

The following statistics account for all incident types, verified, inconclusive, and unfounded:

- Hate bias incident reporting increased by 103.6% in 2023 compared to the previous year.
- There were 316 religion-based incidents, or 33.2%, reported in 2023 compared with 105, or 22.5%, in 2022.
- In terms of bias motivations, Anti-Black or African American accounted for 36.2% while Anti-Jewish accounted for 28.3%. Anti-Gay (Male) is the next highest motivation reported at 8.2%.
- White males as victims of hate or bias accounted for 22.7%, followed by Black males at 22.0%.
- White males accounted for 25.0% of offenders, followed by Black males, the next highest category at 9.9%. The race or gender was not identified for 48.0% of offenders.
- Juveniles accounted for 23.5% of the known victims and 16.4% of the known offenders.
- Incidents reported in October and November were disproportionately higher than any other month.
- As a location type, K-12 schools reported the highest number of hate bias incidents statewide. 326 incidents were reported in 2023 and, of those, 271 were reported in Montgomery County.
- The next highest reporting hate bias locations were Residence/Home (184) and Highway/Road/Alley/Street/Sidewalk (126).
- There were 41 incidents reported at houses of worship with 22 having an anti-religion motivation.
- No hate bias incidents were reported for Garrett, Kent, or Somerset Counties.
- During 2023, 67 incidents were reported involving communication from an offender whose location could be outside of Maryland.

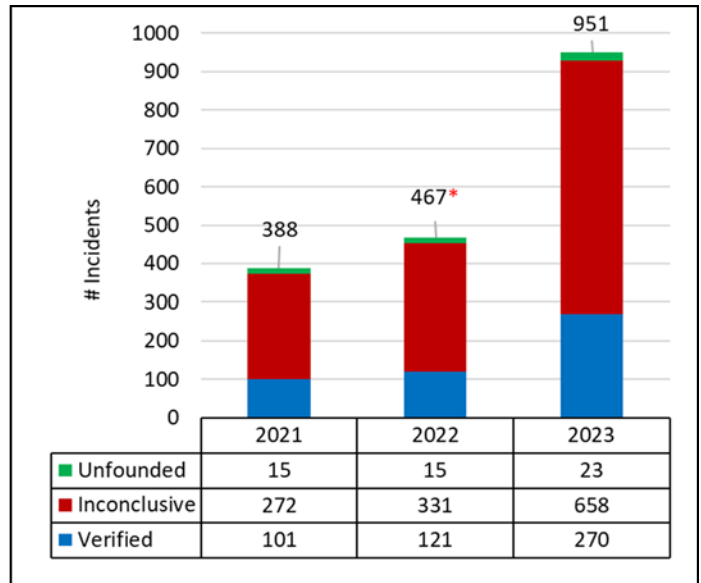


Figure 1: This is a comparison of verified, inconclusive, and unfounded reports for the last three years. **\*Two additional incidents for 2022 were received after publication of the previous year's report.**

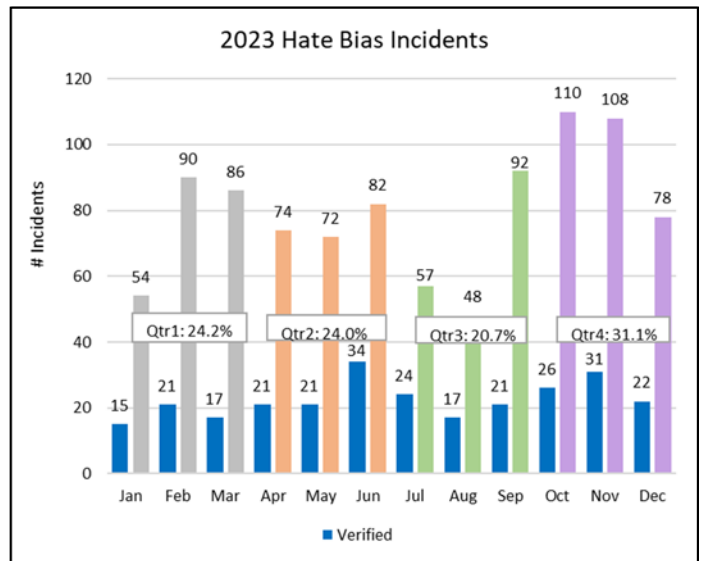


Figure 2: Verified and all incident reporting by month for 2023 are depicted above.

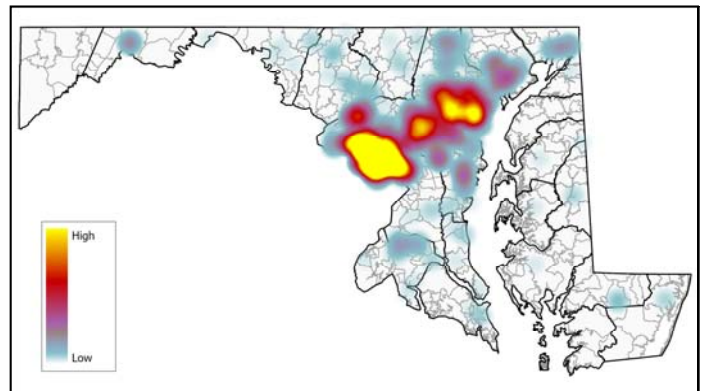


Figure 3: This heat map represents all hate bias incidents reported in 2023.

### IV. Analysis by Category

#### Crime/Incident Classification

Crime/Incident Classification is denoted based on UCR criminal codes and non-criminal codes that correspond with data gathered from the Maryland State UCR Portal.

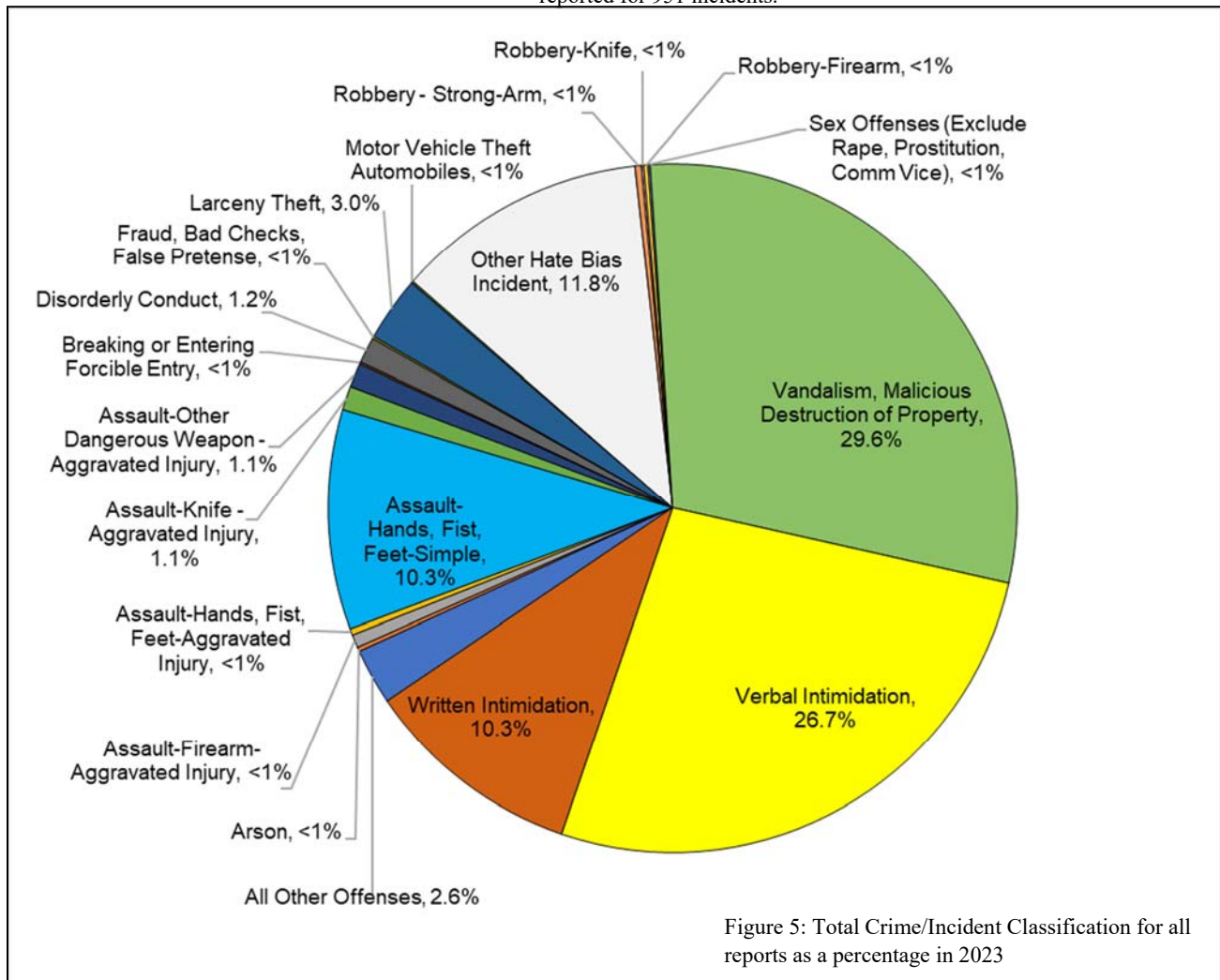


Figure 5: Total Crime/Incident Classification for all reports as a percentage in 2023

**Bias Motivation**

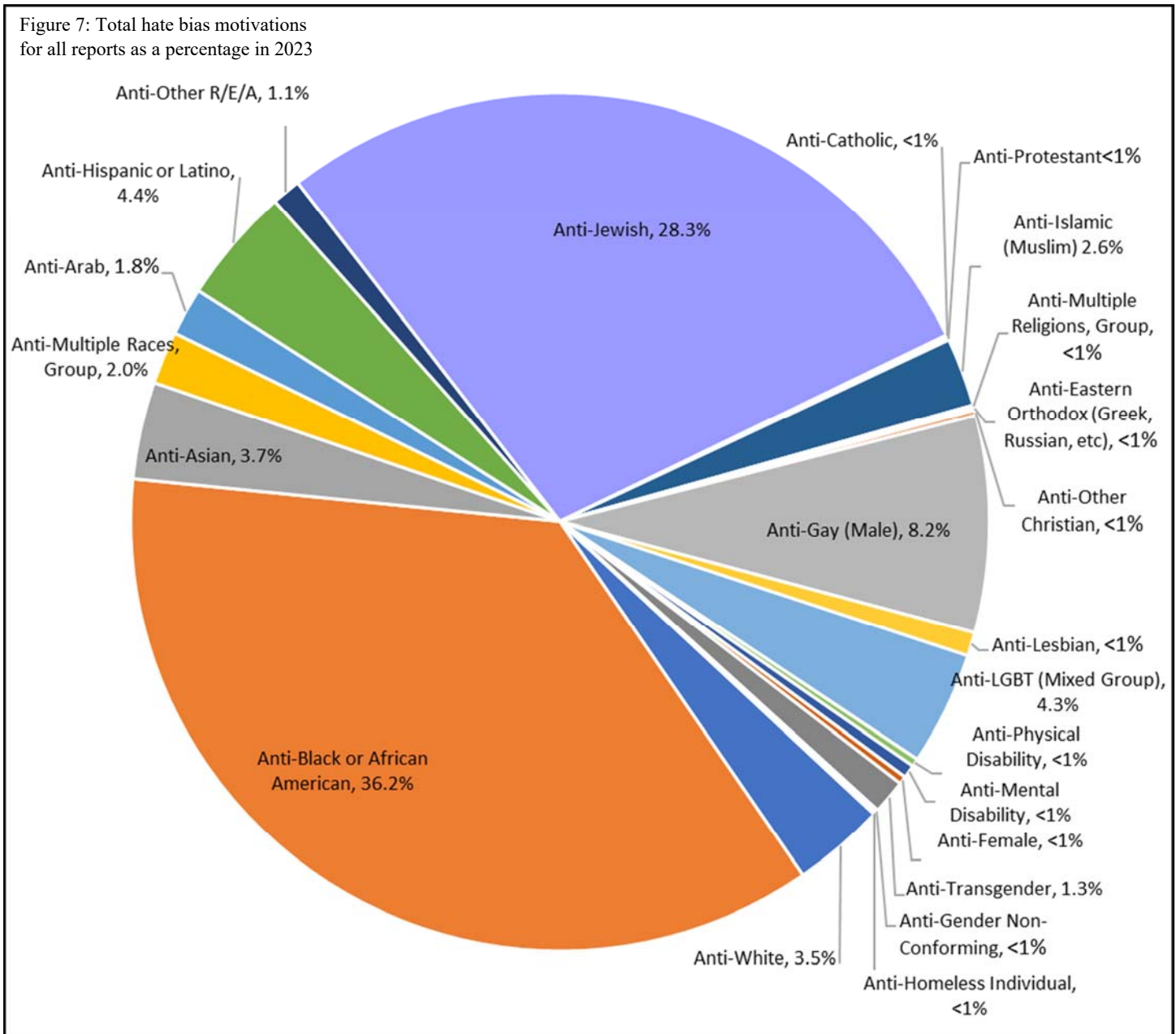
In 2023, R/E/A continues to be the highest category represented for hate bias motivations at 52.6%. Religion-based hate bias motivations changed from 20.7% in 2022 to 31.5% in 2023.

Between 2021 and 2023, the combined reported hate bias motivations involving Disability, Gender, Gender Identity, and Homeless Status accounted for less than 5% each year.

**Victims**

Victim type is categorized into Individual, Business, Financial Institution, Government, Religious Organization, Other, and Unknown. When reporting victim information, all pertinent victim information is recorded, including, but not limited to: age, sex, ethnicity, religion, and sexual orientation. If reporting an event concerning a religious building, for example, the religious affiliation would be pertinent information. Of all reported incidents in 2022, 62.8% of victims were categorized as Individual, followed by Other (16.6%), Government (7.9%), Business (5.4%), Religious Organization (4.6%), and Unknown (2.4%). Three incidents indicated multiple victim types, which accounted for 0.3% of the total incidents for 2023.

**Offenders**

A hate bias incident can be caused by a single individual, a group of individuals. For 2023, 84 incidents reported two or more offenders. One incident had 10 offenders.

Law enforcement reported 14 verified hate bias incidents involving the Goyim Defense League. An additional 15 verified incidents involving ideology or symbols associated with the Klu Klux Klan, Patriot Front, Proud Boys, Nazis or another group were reported.

During 2023, 67 incidents involved the internet, mobile phone, social media, or traditional mail communication by the offender. Of these, 17 were verified.

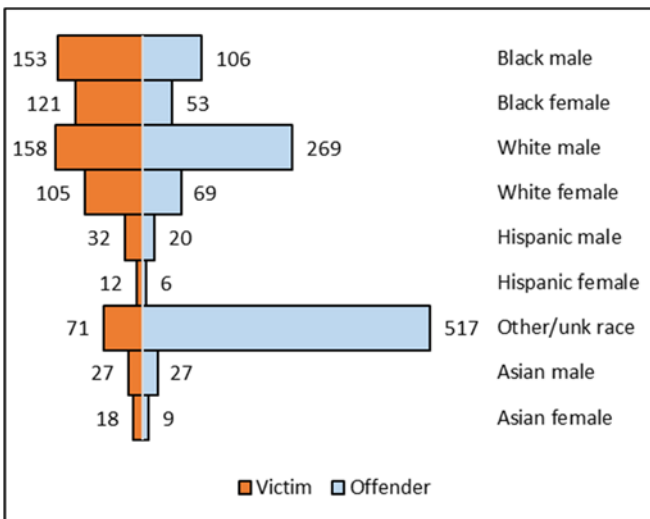


Figure 10: Included on the left is a comparison of race and gender for 2023 victims and offenders.

**Location of Incidents**

There were 32 location types reported for 2023 which include places such as parking garages, restaurants, government buildings, department stores, etc. Of all incidents reported, 34.3% occurred at school-elementary/secondary, 19.3% occurred at a residence/home, 13.2% occurred on a highway/road/alley/street/sidewalk.

**Weapons**

In 2023, 93 reports indicated the use of a weapon. Of these, 58 incidents were verified.

Not all reports indicated a specific type of “personal” weapon used. In other cases, an incident was reported as a simple assault using hands and feet.

**Arrests**

Law enforcement reported 44 incidents closed by arrest in 2023.

**Damages**

In many cases, the damage cost is reported as unknown. Known damage costs incurred for 113 incidents totaled \$79,627. In all but 13 incidents, the incident type reported included some form of vandalism.

### County Trends

- Nearly half (48.7%) of all hate bias incidents reported in Maryland during 2023 were reported in Montgomery County. Nearly a quarter (23.9%) of all hate bias incidents reported in Maryland occurred in one of seven ZIP Codes in Montgomery County. They are 20850 (42), 20817 (38), 20852 (38), 20878 (28), 20901 (28), 20854 (27), and 20877 (26).
- The most hate bias incidents reported by ZIP Code outside of Montgomery County occurred in 20742 in Prince George’s County and 21222 in Baltimore County. Each reported 24 incidents.
- No hate bias reports were submitted by Garrett, Kent, or Somerset counties. This does not suggest that having zero hate bias incidents means no incidents have occurred.

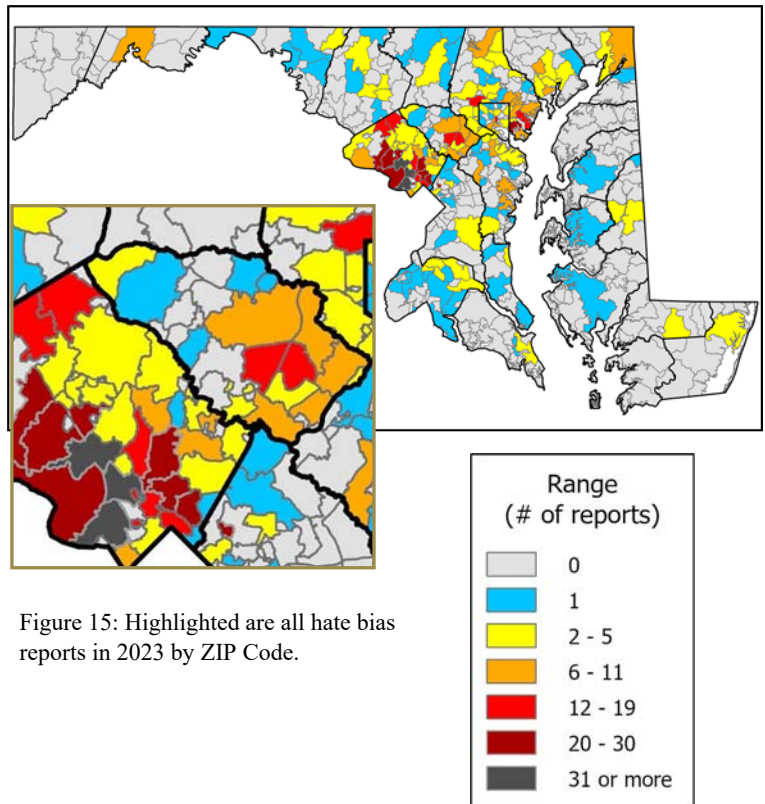


Figure 15: Highlighted are all hate bias reports in 2023 by ZIP Code.

## V. Ten Year Summary

2023 had the highest number of incidents reported during a ten year period with 951. The lowest number of incidents (115) reported was in 2014.

The largest drop in hate bias reporting was also in 2018, with a decrease of 5.8% from the previous year. Linear trend lines for all reports and verified reports indicate an upward trend.

It is important to note that gender and gender identity as protected classes were added in 2015.

### Reporting by County

In 2023, 20 counties and Baltimore City reported at least one hate bias incident. This is the most number of reporting jurisdictions in the last 10 years.



Figure 16: Illustrated above is the percent change by year of total reporting. Percent change refers to change per year compared to the previous year.

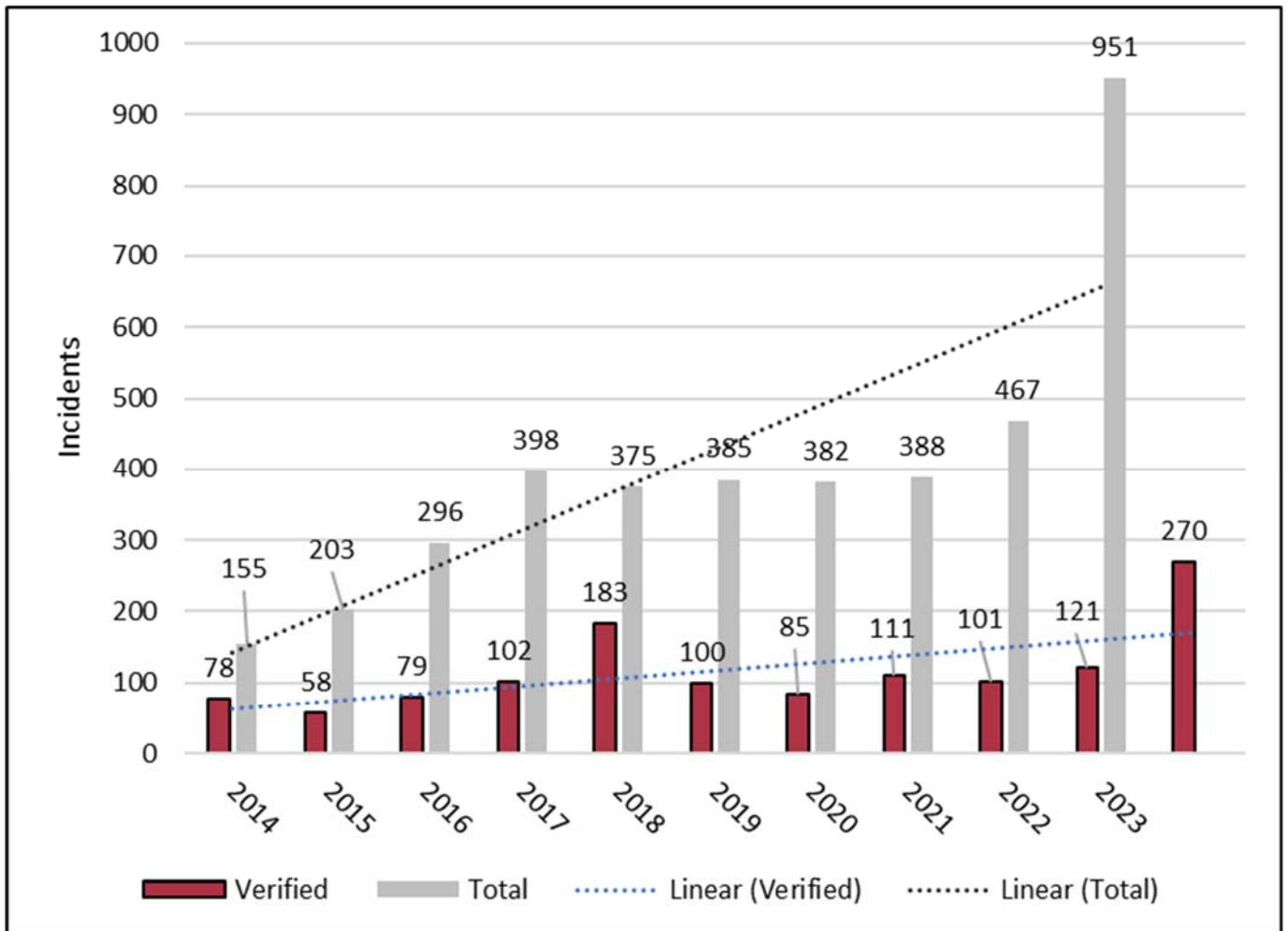


Figure 17: This shows a comparison of verified incidents and all reports from 2014 - 2023. *\*Two additional incidents for 2022 were received after publication of the previous year's report.*

## VI. Considerations

In summary, law enforcement and other human relations agencies across the state should continue to monitor hate bias-related problems in their communities. Maryland citizens and law enforcement agencies must continually be diligent in reporting hate bias incidents. Law enforcement personnel are often the first to arrive on the scene of hate bias incidents. In order to meet the needs of the community, training on the recognition, investigation, and reporting of potential hate bias crimes and incidents remains important. It is equally important to encourage the cooperation of law enforcement and the community in addressing hate bias. The concept of community policing throughout Maryland should continue to incorporate hate bias-related issues.

## VII. Hate Crime Laws

Anti-hate crime acts impacting Maryland include the following:

*The Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act* - On 28 October 2009, President Obama signed this piece of legislation into law. It is attached to the National Defense Authorization Act for fiscal year 2010.<sup>ii</sup> This law expanded existing United States federal hate crime law to include crimes motivated by a victim's actual or perceived gender, sexual orientation, gender identity, or disability, and dropped the prerequisite that the victim be engaging in a federally protected activity.

*Hate Crimes Prevention Act of 1999* - This act prohibits persons from interfering with an individual's federal rights (e.g., voting or employment) by violence or threat of violence due to race, color, religion, or national origin. This act allows more authority for the Federal Government to investigate and prosecute hate crime offenders who committed their crime because of perceived sexual orientation, gender, or disability of the victim. It also permits the Federal Government to prosecute without having to prove that the victim was attacked because he or she was performing a federally protected activity.

*Campus Hate Crimes Right to Know Act of 1997* - This act requires campus security/police authorities to collect and report data on hate crimes committed on the basis of race, gender, religion, sexual orientation, ethnicity, or disability.

*The Church Arson Prevention Act of 1996* - This act created the National Church Arson Task Force (NCATF) in June 1996 to oversee the investigation and prosecution of arson at houses of worship around the country. The NCATF has brought together FBI, Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF), and Department of Justice prosecutors in partnership with State and local law enforcement officers and prosecutors. In addition to the NCATF's creation, the law allowed for broader federal criminal jurisdiction to aid criminal prosecutions and established a loan guarantee recovery fund for rebuilding.

*The Hate Crimes Sentencing Enhancement Act* - As a part of the 1994 Crime Act, the Hate Crimes Sentencing Enhancement Act provides for longer sentences when the offense is determined to be a hate crime. A longer sentence may be imposed if it is proven that a crime against a person or property was motivated by "race, color, religion, national origin, ethnicity, gender, disability, or sexual orientation."

*The Hate Crimes Statistics Act of 1990* - This act requires the Department of Justice to collect data on hate crimes. Hate crimes are defined as "manifest prejudice based on race, religion, sexual orientation, or ethnicity." The FBI compiles these statistics using the Uniform Crime Reporting (UCR) system. The Crime Act of 1994 also requires the FBI to collect data on hate crimes involving disability.

*Maryland Code Public Safety § 2-307* - "(a) The Department shall collect, analyze, and disseminate information about the incidence of crime in the State. (b) (1) The Department shall collect and analyze

information about incidents apparently directed against an individual or group because of race, religion, ethnicity, or sexual orientation.

Maryland extended hate crimes protection to homeless people under a bill signed on 7 May 2009. The bill added homeless status to the protected categories under Maryland's hate crimes law, allowing prosecutors to seek tougher penalties as they do for those who target people because of factors such as race, ethnicity, religion, and sexual orientation.<sup>iii</sup>

In 2019, Public Safety Article 20 Section 2–307 modified hate bias reporting requirements to collect and analyze incidents directed against an individual or a group because of color, religious beliefs, sexual orientation, gender, disability, national origin, or homelessness.

*Maryland Code Criminal Law Subtitle 3 § 10-304* added homeless persons and groups and gender to the protected classes under State hate crime statutes. "Because of another's race, color, religious beliefs, sexual orientation, gender, disability, or national origin, or because another is homeless, a person may not: (1-i) commit a crime or attempt to commit a crime against that person; (1-ii) damage the real or personal property of that person; (1-iii) deface, damage, or destroy, or attempt to deface, damage, or destroy the real or personal property of that person; or (1-iv) burn or attempt to burn an object on the real or personal property of that person."

In March 2014, the Maryland General Assembly passed legislation adding "transgender" people to the list of protected classes. The law prohibits discrimination based on gender identity in housing and employment, in obtaining credit, and in access to public accommodations. This law took effect on 1 October 2014.<sup>iv</sup>

In 2020, Criminal Law Section 10–305.1 was modified, and now prohibits a person from using an item or symbol, including a swastika or a noose, to threaten or intimidate another, creating criminal and monetary penalties.

Maryland General Assembly modified the same section again redefining gender identity to align with the definition with other laws.

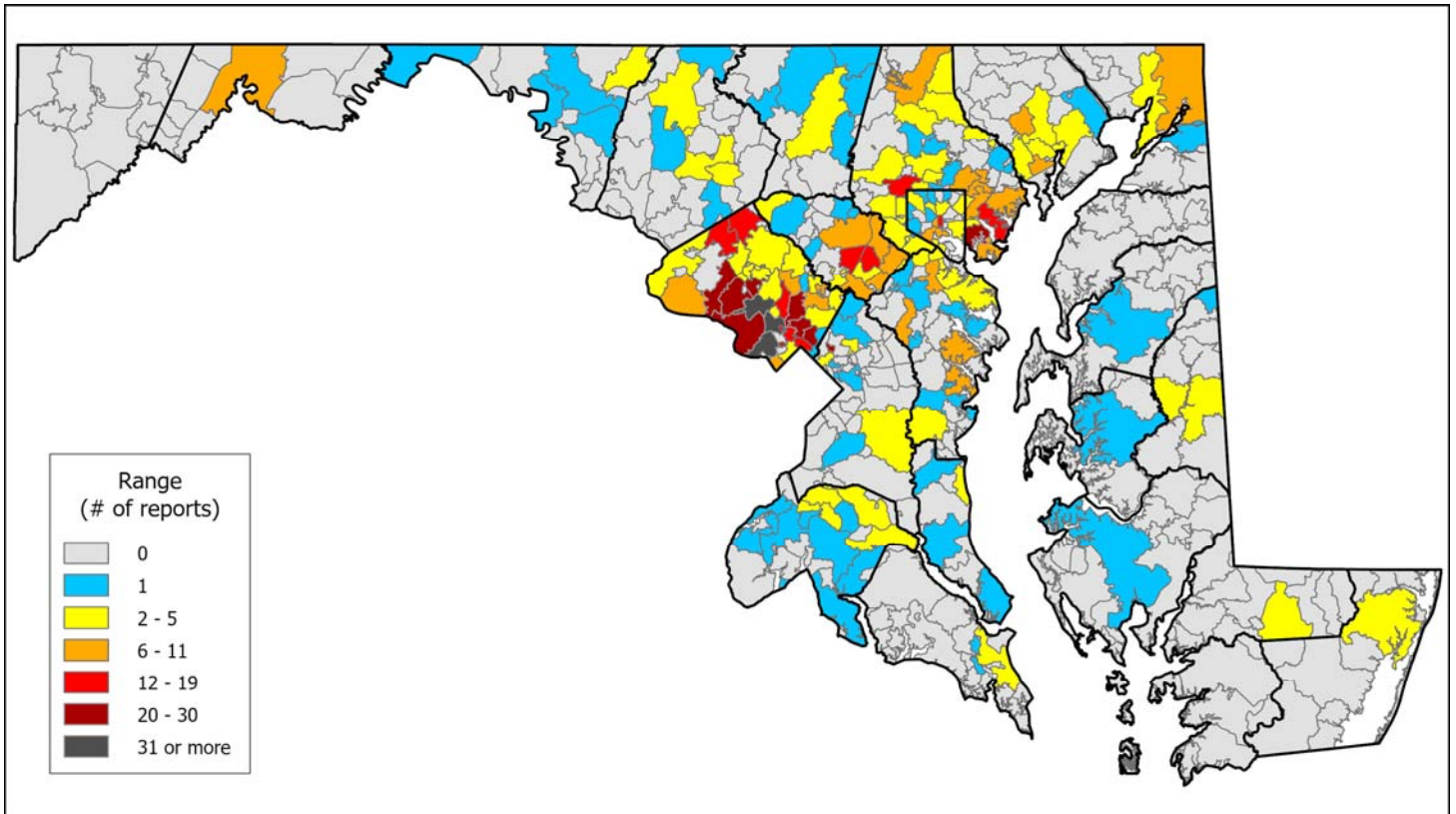


Figure 15 (Enlarged from page 11): Highlighted here are all hate bias reports in 2023 by ZIP Code.

**The data behind this report comes from the Maryland Supplementary Hate Bias Incident Reporting, which is mandated for all Maryland law enforcement agencies to complete when a hate bias incident is encountered. The requirement collects information on date, time, incident type, bias motivation, clearance, victim and offender demographics, location, weapons used, injuries, value of property damage, and a written summary of the incident, amongst other things.**

**The information reported is based on individual agency policy and procedures, as well as the individual officer's level of training and expertise. The reports are collected by the Maryland Department of State Police Central Records Division as mandated by law and are then provided to the MCAC. If a hate bias incident occurs and is not reported to law enforcement, an incident report is not filled out and is not submitted. All incidents included in this analysis are counted as to what they are marked upon their most current receipt. This analysis is current as of 1 July 2024. Incident reports received after 1 July 2024 will be reflected in the 2024 report.**

**Assistance from the Maryland State Police and the Maryland Coordination and Analysis Center is available to any law enforcement agency that collects the information for investigative and reporting purposes.**
