Integrated Mechanical Safety Devices

The Board voted 7-1 to approve Project ChildSafeSM Cable Lock for addition to their Approved Safety Devices list. The Maryland Handgun Roster Board approves integrated mechanical safety devices for either factory, distributor, importer aftermarket installation, or by licensed firearms retailers. Installation of any of these listed devices in an approved handgun when sold satisfies Maryland law.
