Any firearm approved at this meeting will be published in the Maryland Register on July 1, 2022 and, barring no objections, will be included on the Maryland State Police website on July 31, 2022 as a handgun, model and caliber legal for sale in the State of Maryland.

Additional Discussions

Smart Gun Report

The Board considered and unanimously passed their annual report on the status of personalized handgun technology. This requirement was part of the Responsible Gun Safety Act of 2000, and subsequently incorporated into Public Safety Article, §5-132(d).

Integrated Mechanical Safety Devices

The Board voted unanimously to approve SFUS, Inc.'s SafeGunLock for addition to their Approved Safety Devices list. The Maryland Handgun Roster Board approves integrated mechanical safety devices for either factory, distributor, importer aftermarket installation, or by licensed firearms retailers. Installation of any of these listed devices in an approved handgun when sold satisfies Maryland law.
