Minutes

The minutes from the March 10, 2021 meeting were approved unanimously.

Announcements

Any firearm approved at this meeting will be published in the Maryland Register on July 2, 2021 and, barring no objections, will be included on the Maryland State Police website on August 1, 2021 as a handgun, model and caliber legal for sale in the State of Maryland.

Additional Discussions

Smart Gun Report

The Board considered and unanimously passed their annual report on the status of personalized handgun technology. This requirement was part of the Responsible Gun Safety Act of 2000, and subsequently incorporated into Public Safety Article, §5-132(d).

New Board Members

Present at the meeting was Mr. J. Charles Smith, the newly appointed Representative of the Maryland State's Attorney Association, appointed to fill the vacancy created by Mr. Michael O. Twigg, Esq; Mr. Robert Bajefsky, the newly appointed Representative of Maryland Advocates Against Handgun Violence, appointed to fill the vacancy created by Mr. Nicholas Wilson; and Ms. My Harrison, the newly appointed Citizen member, appointed to fill the vacancy created by Mr. Charles Robinson. All were introduced to their fellow board members, and having been previously briefed on the Board's procedures and agenda, participated in the days voting.

Model Number Elimination

Due to ongoing complications stemming from the inclusion of “model numbers” on the handgun roster, the HRB was informed of the administrative change as there is no legal requirement to include them and of the historical issues that have arisen due to the use of model numbers. The HRB will no longer consider model numbers effective July 1st, 2021. The "Model Numbers" category on the Maryland Handgun Roster will be renamed to "Model Description," which will remain for historical purposes and as an optional entry on the 77R application. N/A will be added as an additional option to all entries under "Model Description" for convenience. HRB Petitions for model number additions will no longer be accepted. Only petitions for caliber additions and model additions will be submitted for consideration. Model additions, to include new models and mechanical modifications, such as but not limited to frame size, slide length, and internal mechanical component changes to approved models. For the day’s voting, the HRB only voted on new models, model additions, and caliber additions. There were no objections from the HRB regarding model number elimination.

Integrated Mechanical Safety Devices

The Board voted unanimously to approve the 33 safety devices from REGAL INDUSTRIAL SALES, INC. / FSDC for addition to their Approved Integrated Mechanical Safety Devices list. The Maryland Handgun Roster Board approves integrated mechanical safety devices for either factory, distributor, importer aftermarket installation, or by licensed firearms retailers. Installation of any of these listed devices in an approved handgun when sold satisfies Maryland law.
