Any firearm approved at this meeting will be published in the Maryland Register on September 24, 2021 and, barring no objections, will be included on the Maryland State Police website on October 24, 2021 as a handgun, model and caliber legal for sale in the State of Maryland.

### **Additional Discussions**

#### **Integrated Mechanical Safety Devices**

The Board voted 8-1 to approve the FSDC-LL675RKD Lever Action Lock Family and Regal M2006 Trigger Lock from Regal Industrial Sales, Inc. / Firearm Safety Devices Corporation; the Internal Chamber Block (9 mm, 40 S&W, and 45 ACP) from Omega Safety Systems, Inc.; the Cable Lock Complete and Base from Birotech, Inc.; and the Chamber to Muzzle, flexible, internal, gun barrel lock (Pistol, Rifle, and Shotgun lock) from Savage Mountain Firearms, LLC for addition to their Approved Safety Devices list. Board Member Bajefsky was the dissenting vote for all stating that none are IMSDs. The Maryland Handgun Roster Board approves integrated mechanical safety devices for either factory, distributor, importer aftermarket installation, or by licensed firearms retailers. Installation of any of these listed devices in an approved handgun when sold satisfies Maryland law.
