The following handguns have been specifically disapproved by the Maryland Handgun Roster Board for inclusion on its list of handguns approved for manufacture and sale in Maryland. The list reflects action of the Board as of the date indicated above. Handguns manufactured after 1985 can only be sold in Maryland if the Handgun Roster Board has specifically approved them for sale and placed them on the Official Handgun Roster. Therefore, the fact that a handgun does not appear on this list of disapproved guns does not automatically mean that it is an approved gun.
